GENERAL TERMS OF THE EXHIBITION

I.

General terms of the exhibition (hereinafter: General Terms) define the relation between legal or natural person who filled in the Application form, as the **Exhibitor**, and the Business Center Virovitica Ltd. as the **Organizer**.

II.

The Exhibitor registers his participation on the **15th International Fair of Economy, Trades and Agriculture from January 22. – 24. 2010.** (hereinafter: **Fair**) by the Application form which is a component part of these General Terms. By signed and stamped Application form, the Exhibitor declares that he is compliant with General terms and accepts them.

III.

The Organizer has the right to cancel Exhibitors participation on the Fair if he determines that the Application is not in line with the content and the quality standard of the Fair or due to some other relevant reasons. The Organizer has the right to forbid the exhibition and move the products from the exhibition space, if he determines that those are the ones that are not in line with the Exhibitors` statements, and eliminate them on Exhibitors` expense. If the Fair schedule implies so, the Organizer can approve up to 25% smaller or bigger size of the space from applied one.

IV.

The Exhibitor is not allowed to sub-rent the exhibition space or a part of the exhibition space, without the prior approval of the Organizer.

V.

In the case that the Exhibitor cancels already concluded Application, he is obliged to cover all incurred expenses. The Exhibitor must inform the Organizer on canceling the exhibition, in writing, 15 days before the beginning of the Fair. If the Organizer does not accept cancellation of the participation or if it is delivered in a period shorter than 15 days prior to the beginning of the Fair, the Exhibitor will be charged total ordered space and all services provided till then.

VI.

The Exhibitor is obligated to arrange and equip his exhibition-sales space no later than one day prior to the beginning of the Fair.

VII.

The Organizer also has the right to reject the Application in following circumstances:

- if the Exhibitor is, in the time of the application, in insolvency or in the procedure of liquidation,
- if the Organizer has unpaid claims towards the Exhibitor,
- if the Exhibitor does not deliver needed documentation on Organizers request,
- if the requested space is already sold out.

VIII.

The Exhibitor will conduct direct sale on the Fair in line with the valid regulations and if he is registered for it.

IX.

The Exhibitor is obliged to insure his equipment and exhibition assets form damage, destroying, breaking, break-in, stealing, in case of elementary disaster or force majeure at the insurance company, and is obliged to respect the rules and regulations on fire security, to maintain the exhibition-sales space on his account,

to be present in his exhibition space during the Fair working hours from 8 till 19, after the Fair is finished to give over the space and equipment in condition like when it was taken over, to immediately cover the expenses of every damage incurred, to cover the expenses to the Organizer for the rent of exhibition-selling space and the expenses of ordered technical services immediately after the offer is issued, and to immediately accept written reclamation.

X.

The Organizer will, according to the filled Application, issue the offer for ordered exhibition-sales space and for basic technical services that is paid immediately to the Organizers account 2360000-1102064788 at Zagrebačka banka d.d. After the payment, the Organizer will deliver the bill to the Exhibitor with the final calculation of the services according to the Application, as well as with all other additional costs. The Exhibitor is obliged to make payment to the Organizers account in a deadline stated in the offer. After the payment within a deadline stated in the offer, the Organizer guaranties arranged space and position. For each day of crossing the deadline for payment, we are charging statutory default interest. Reclamation on the bill is delivered within 10 days from the date of issuing. Additional complaints will not be considered.

XI.

After the payment is completed, the Exhibitor is entitled to receive Fair Identification Cards without charge, depending on the size of rented exhibition-sale space.

For indoor space up to 9 m² or open-air space up to 50 m² – two (2) identification cards, and for every further 9 m² of indoor, and 50 m² of open-air covered/open-air space, two (2) cards.

XII.

The Exhibitor can start with the arrangement of the exhibition space three days prior to the beginning of the Fair, and must empty it the next day after the Fair is finished. If the Exhibitor does not empty the exhibition space according to the deadline, the Organizer is not taking any responsibility for the exhibitors goods. Due to special circumstances, defined deadlines can be prolonged or shortened.

Adjustment and dismantling of the exhibition space is approved in above mentioned time from 7 am until 3 pm, or according to the agreement.

XIII.

In case that the Exhibitor violates any of the above mentioned decisions, the Organizer has the right to prohibit its participation on the Fair. In that case, the Exhibitor is obliged to cover all of the expenses from the General Terms and all other possible costs. For all unsolved debts from the Exhibitor, the Organizer has the right to keep all goods brought to the Fair up to the amount of uncompleted obligations. The Organizer will store retained goods with the charge and the expenses covered by the Exhibitor.

XIV.

In case of conflict, the Court in Virovitica rules on jurisdiction

XV.

These General Terms have the same importance as the Contract to rent or temporary use exhibition space of the Fair.
